

TERMS OF SERVICE

Welcome to Digitaldevils LLC. These Terms of Service ("Terms", "Agreement") govern your access to and use of the internet platform, software, and related services (collectively, the "Service") provided by Digitaldevils LLC ("Company", "we", "us", or "our").

 - Is fraudulent, deceptive, or intentionally harmful to the platform or other users.
